Auckley Neighbourhood Plan Decision Statement

1. Summary

1.1 Following an independent examination, the City of Doncaster Council confirms that the Auckley Neighbourhood Plan will proceed to a Neighbourhood Planning referendum.

2. Background

2.1 On 11th June 2018, the City of Doncaster Council (then Doncaster Metropolitan Borough Council) designated the Auckley area for the purpose of preparing a Neighbourhood Plan in accordance with Part Two of the Town and Country Planning (England), Neighbourhood Planning (General) Regulations 2012.

2.2 Following the submission of the Auckley Neighbourhood Development Plan to the Council in July 2022, the plan was publicised and representations invited. The publicity period ended on 26th September 2022.

2.3 The Council appointed an independent examiner, Peter Biggers BSc Hons MRTPI, in November 2022, to undertake an examination of the Plan, to review whether the Plan meets the basic conditions and should proceed to referendum.

2.4 The examiner's report, received January 2023, concludes that, subject to a number of modifications specified in the report, that the Plan meets the basic conditions set out in legislation and should proceed to a Neighbourhood Plan referendum.

2.5 Therefore to meet the requirements of the Localism Act 2011 a referendum, which poses the question 'Do you want the City of Doncaster Council to use the Neighbourhood Plan for Auckley to help it decide planning applications in the neighbourhood area?' will be held in the Auckley Parish boundary, as designated.

2.6 The date on which the referendum will take place is agreed as Thursday 20th April 2023.

3. Decision and Reasons

3.1 Having considered the recommendations made by the examiner and the reasons for them, the Council has decided to make the modifications to the draft plan as set out in Table 1 below:
